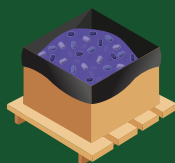
What Is RightCycle by Kimberly-Clark Professional®?

1. Contact your local Kimberly-Clark Professional representative or e-mail rightcycle@kcc.com to learn about how this program can benefit your business.
2. Collect used, non-hazardous Kimberly-Clark Professional apparel items, eyewear, disposable respirators and nitrile gloves in receptacles located throughout your facility.
3. Consolidate used products on a pallet and ship the full pallets to our Kimberly-Clark recycling centers.
